EWC and SE Introductory Seminar

Montabaur castle, 22 - 25 April 2025

From 22 to 25 April 2025, the annual basic seminar for members of European Works Councils, SE Works Councils and Special Negotiating Bodies will take place in Montabaur. The castle is located at the ICE railway station halfway



between Frankfurt and Cologne. Several seminar modules for beginners and advanced participants will be offered there.

Hamburg Conference for European and SE Works Councils

Hamburg, 26 + 27 January 2026

As every year since 2009, our twoday conference will again take place at the Hotel Hafen Hamburg. The agenda includes current trends in the EWC landscape with practical examples.



Legal basis for attending the conference:

Members of European Works Councils from EU countries as well as the Norway, Iceland and Liechtenstein can request central management for timeoff work and to cover conference expenses under Article 10(4) of EU Directive 2009/38/EC. In most cases the EWC agreement or the SE Participation Agreement explicitly provides for an entitlement to training. This usually also applies to delegates from Switzerland, the UK and other non-EU countries. Members of European works councils governed by German law may attend in accordance with Article 38 (1) of the German EWC Act. Members of SE works councils governed by German law may participate in accordance with Article 31 of the SEBG. German works council members may attend in accordance with Article 37 (6) of the Works Constitution Act.



Legal EWC seminar in Dublin

With a visit to a court hearing at the High Court

Dublin, 30 June to 3 July 2025

Legal basis for participation to the conference: Article 37 (6) German Works Constitution Act or Article 38 (1) of the German EWC Act i.c.w. Article 10 (4) of the EU¬ Directive 2009/38/ECG In recent years, there has been an increase in legal disputes concerning European Works Councils, many of which have involved companies from the US, the UK, Ireland, Switzerland and other Anglo-Saxon countries. However, companies in France, Germany, Austria, Italy, Finland and Norway have also been affected. The seminar will cover court cases from recent years. Particular emphasis will be placed on the situation in Ireland, where a case is pending before the High Court that could potentially end up before the European Court of Justice. The seminar includes a visit to the oral hearing at the High Court.

- European Works Council case law in recent years
- The distinguishing features of EWC work with Anglo-Saxon management
- The particularities of Irish EWC law
- Two examples of new EWC agreements

Who should attend?

This seminar is aimed at members of European Works Councils and SE Works Councils who want to familiarise themselves with the experience gained so far in case law across Europe, whose management or whose agreement is Anglo-Saxon oriented and/or is subject to Irish law.

 The Adecco EWC agreement and its background

In October 2024, a new EWC agreement under Irish law was signed for the Swiss HR services provider Adecco. It sets a standard that had not existed before in Ireland. Previously, the EWC was subject to UK law and had filed legal proceedings against the central management before Brexit that ended up in the Supreme Court. All proceedings have been settled with the signing of the new EWC agreement.

 Practical EWC work and features of the Amazon EWC agreement

In May 2022, an EWC agreement was signed in Dublin for Amazon. The EWC is a forum of management and employee representatives covering 240,000 employees in the e-commerce sector. Despite Brexit, the United Kingdom has been fully integrated into the EWC.

 Legal proceedings under British and Irish law

In August 2024, the Labour Court in Dublin declined jurisdiction to rule on an EWC legal issue. The Irish EWC Act (TICEA) only provides for legal recourse for individual claims, but not for collective disputes. The EWC has appealed to the High Court. Verizon already had several complaints in the UK before Brexit.
